Essential Qualification (EQ) for the Post is as below:

- b) *Professional Skill in driving, knowledge of motor mechanics, and holding of valid permanent licence for driving cars and heavy vehicles, having at least four years' experience in driving issued by State Government or Central Government or Union Territories.*
