F. No. HQ-C1102/9/2025-C-1: Candidates may refer to the Notice dated 23.06.2025 of the Combined Higher Secondary (10+2) Level Examination (CHSLE) -2025. Para 13.8.13.7 (vii) of the said Notice stands amended and may be read as under:

“Para 13.8.13.7 (vii) Persons with Disability (PwD), who are otherwise qualified to hold the post(s) and who are certified as being unable to type by the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution, may be exempted from passing the typing test. Such certificate shall be submitted in the prescribed format (**Annexure-XIV**). The term ‘Persons with Disability (PwD)’, in this case, does not cover those who are visually handicapped or who are hearing handicapped but covers only those whose physical disability permanently prevents them from typing. In addition, such candidates must substantiate their claim by furnishing the relevant Medical Certificate, as applicable, in the prescribed format as per **Annexure-XI** to **Annexure-XIII** of the Notice of Examination, alongwith an Undertaking as per the format attached, on the email IDs of their respective Regional Offices, as mentioned below, by 09.04.2026 (12:00 noon):
